Like their counterparts on the men's side, the womer's field is heavily dominated by the power leagues, with the ACC re-ceiving six bids and the Big Ten claim-ing five. On the whole, however, the womer's field is nore nationally repre-sentative than the meris tournament sentative than the men's tournament with more schools in the western half of the country fielding varsity programs at the sport's top level. 
