HILLSBOROUGH COUNTY PUBLIC SCHOOLS PROCUREMENT SERVICES DEPARTMENT

This Agreement is entered into by and between The School Board of Hillsborough County, Florida, a public body corporate acting for Hillsborough County Public Schools, whose principal address is 901 East Kennedy Boulevard, Tampa, Florida 33602 (hereinafter referred to as "HCPS") and Safeware, Inc., whose principal place of business is 4403 Forbes Boulevard, Lanham, Maryland 20706 (hereinafter referred to as the "Contractor"), collectively, the "Parties" and each individually a "Party".

WHEREAS Hillsborough County Public Schools ("HCPS") issued this competitive solicitation ("solicitation"), in accordance with Rule 6A-1.012, F.A.C., to accept proposals from all qualified firms or individuals interested in providing the services as described herein. The proposer must demonstrate by their qualifications, experience, availability, approach, and work plan that they will best serve the overall needs of HCPS; and

WHEREAS HCPS, on behalf of itself and all states, local governments, school districts and higher education institutions in the United States of America, and other government agencies and nonprofit organizations (herein "Participating Public Agencies") solicited proposals from qualified suppliers to enter into a Master Agreement for a complete offering of Public Safety and Emergency Preparedness Equipment, and Related Products and Services (herein "Products and Services"); and

WHEREAS the Contractor submitted a proposal to HCPS' solicitation, 24101-RFP-DST for Public Safety and Emergency Preparedness Equipment and Related Products and Services; and

WHEREAS after verification of the proposals, HCPS has accepted the Contractor's proposal as the highest ranked and best value to The School Board of Hillsborough County, Florida and enters into this Agreement in accordance with the terms and conditions of the solicitation.

NOW, THEREFORE, the parties hereto agree as follows:

Initial Term. The Initial Contract Term will be for five (5) years. The Initial Contract Term shall begin on October 2, 2024, or the last date upon which this Contract is signed by all Parties.

Renewal Term(s). Upon mutual written agreement, HCPS and the Contractor may renew this agreement, in whole or in part, for a Renewal Term not to exceed the Initial Contract Term of five (5) years, pursuant to the incorporated Scope of Work.

Agreement. As used in this document, the term "Agreement" (whether or not capitalized) shall, unless the context requires otherwise, be considered to be references to this Agreement, including all Exhibits attached, which set forth the entire understanding of the Parties and supersedes all prior agreements, whether written or oral, with respect to such subject matter. All Exhibits attached to this Agreement are incorporated in their entirety into, and form part of, this Agreement. The Agreement has the below Exhibits. In case of conflict, the terms of this Agreement shall control. If a conflict exists among any of the attached documents, the documents shall have priority in the order listed:

- Exhibit A: Request for Proposal 24101-RFP-DST: Public Safety and Emergency Preparedness Equipment and Related Products and Services, all attachments and posted addenda, and the Safeware, Inc. submitted Proposal.
- Exhibit B: Price Sheet(s)
- Exhibit C: Market Basket Pricing Analysis

Rebate Programs. Many Contractors' customers have rebate and incentive programs based on customer requirements. Rather than offering a single program for all public agencies, the Contractor will continue following individual customer incentives. Such rebates are not formulaic; the Contractor will work with each specific entity to offer rebates tailored to their purchase.

Amendments. No oral modifications to this Agreement are acceptable. All modifications to this Agreement must be in writing and signed by all Parties. Any future amendments of this Agreement which alter the definition of the Statement of Services shall define the Services or Solution in the same format as the Scope of Services.
